In accordance with the terms of the By-laws of the Swan Valley Credit Union, your organization can be represented at meetings of the Credit Union's members. It can exercise all the powers an individual member can exercise, including the right to vote. These rights must be exercised by an individual appointed by your organization for that purpose.

The Credit Union's annual meeting is scheduled for Monday, April 23, 2018. Advance ballots for the election of Credit Union directors may be cast in person during normal business hours from April 16<sup>th</sup> to April 20<sup>th</sup>, 2018 inclusive in Swan River and Benito. Ballots must be cast on the form approved by our Returning Officer.

I urge you to appoint a representative so that your organization can participate in our democratic process. Your Credit Union is based on the co-operative principle of one member, one vote. Every member's participation is important. Our system needs your participation to function effectively for the benefit of all members.

Please appoint a representative who can act on your behalf during our upcoming election. Once your representative has been appointed please complete the form on the reverse and mail/deliver it to our Swan River office. We will verify the information and confirm details with your representative when he/she comes in to vote during election week or at the annual meeting.
